Sales Discount 2010

A Sales Discount will be credited to the current consumer at each metered supply point (ICP) at the discount date of 31 January 2010. The discount will be 15% of the total fixed and variable Network (Line and Transmission) charges paid by that consumer at that ICP for the previous twelve months.

Power Factor Charge

This applies to commercial customers. Where the power factor is less than 0.95 Electra reserves the right to impose a power factor charge. The charge will be based on a multiplier of 2% of the monthly total Network charges for every 0.01 power factor below 0.95 lagging.

Closed Option

The Combined option is no longer available except to existing users.
